- Alderman Rose commented that there was a reduction in square metres from last year. The CEO advised that from the tenders submitted there was a massive variation in cost. Prices from last year on comparison are down which enables Council to get some more work done.
- Alderman Gazey asked about the quality of work asked that there was no question of there being a cheaper job. The CEO commented that the companies that tendered are reputable companies and have a reputation to maintain. Council will be monitoring their work. There can be no guarantee of the quality of work but processes will be monitored.

Alderman Phillips asked for clarification on meetings the Mayor had;

- the meeting with member of the public x 7. The Mayor had advised that there were various reasons for the meetings that members of the public had requested.
- The moving of the train the Mayor advised that there had been a meeting to discuss this. This will happen when funding is available. The train will be moved and fenced.
- Alderman Tapp-Coutts; a member of the public approached her about closing Hibiscus Lane, from around 9pm 6am. Asked what was happening with this. The Mayor advised that this has been discussed before with the owner of the house who lived adjacent to the lane re opening and closing the gates. Rangers closed it for a period of time. Fences were wrecked. Painted Indigenous artwork on fences this also did not work. The only lane that worked was one where there was a total closure and completely blocked off Glencoe with the land being purchased by an adjoining owner.
- Alderman Phillips advised that a lane which was fenced off stopped others like wheelchair users and mothers with prams using the lane.
- The Mayor spoke also about the Principal of Katherine High School who has spoken about vandalism and the lane being used as an escape route.
- The Mayor advised this would be discussed at a workshop.
- Alderman Tapp-Coutts will suggest that the member of the public should come and speak to the Mayor to get the background history.
