- Alderman Rose noted in previous policy there was a member on the national Nitmiluk Board and this is omitted and also the Mt Todd Reference Group from the last policy is not included and Katherine Tourism Committee not included. The Mayor advised that these Committees were external, not Council run, and that Council had not appointed anyone to the Mt Todd and Katherine Tourism Committee groups.
- The Economic Development Manager there was an expectation that he would be partly funded by taking on work from other agencies and queried this. The CEO confirmed the appointment of the Economic Development Manager was not based on this expectation
- Assets and Infrastructure need to be catalogued with a record of condition for budgeting requirements. The CEO confirmed that the position description for the Manager Assets and Infrastructure was still a work in progress..
- Alderman Ganley queried page 52 clarification on the extent of the functions of Council and housing and community amenities. It was confirmed that the house at the Katherine Musuem was listed as an asset.
