Aquatic centre civil works have commenced. Final agreement with the contractor has been reached. Due to the increase in costs the Splash Zone will now not be funded by the grant.

Funds for the Splash zone is being investigated.

Civic centre upgrade loan approved by the Minister is to provide the upgrade to the whole building, not only the roof. Works required include non-compliant infrastructure such as the access ramp and air-conditioning, disabled access, WiFi and audio capabilities, hot water system and other elements needing to be upgraded.

Fee for a burial includes a plaque and its installation. At the moment there is an ongoing audit of the current plots. Missing plaques have been identified and being replaced.

Council is looking at different organic spray options for weeds. In discussions with local suppliers costs are higher therefore developing a trial for a small testing area that will be tabled to Elected Members once more information available.
