Summary of Decision

Complainant: Beverley Ratahi

Respondent: Councillor Amanda Kingdon

Date of Decision: 27 February 2024

Description of Conduct: On Tuesday 13 February 2024 the CEO received two informal complaints regarding a social media post by Councillor Amanda Kingdon against the NT Independent Facebook post regarding Minister for Local Government Chansey Paech declaring shares in a company that wholesales alcohol in the NT.

Councillor Amanda Kingdon made the comment on her Councillor Facebook profile: ‘Dishonourable and shameful. I hope this is dealt with and any parliamentary bonuses taken away. I’m fighting for peace and harmony in our Town serving the people on a taxable allowance of \$20k a year. No shares or investment houses and volunteering many hours to help people, struggling to make ends meet. Our Minister of local Government Shame’.

At the EMIS Monday 19 February 2024 Elected Members discussed and deliberated the informal complaint. Council noted this is not the first breach of the Code of Conduct Policy by Councillor Amanda Kingdon who had received at least three training sessions to date.

Code of Conduct Contravened:

1. HONESTY AND INTEGRITY A member must act honestly and with integrity in performing official functions.
2. CARE AND DILIGENCE A member must act with reasonable care and diligence in performing official functions.



3. COURTESY A member must act with courtesy towards other members, council staff, electors and members of the public
10. ACCOUNTABILITY A member must be prepared at all times to account for the member's performance as a member and the member's use of council resources.
11. INTERESTS OF MUNICIPALITY, REGION OR SHIRE TO BE PARAMOUNT A member must act in what the member genuinely believes to be the best interests of the municipality, region or shire.

Recommendations made by Council:

That Councillor Amanda Kingdon has breached the Code of Conduct and Social Media policy with the following affirmative actions be taken for a period of 12 months:
